

The Terms and Conditions were last updated on January 19, 2025.

1. Introduction

These Terms and conditions apply to this website and to the transactions related to our products and services. You may be bound by additional contracts related to your relationship with us or any products or services that you receive from us. 2. Binding

You will be provided a refund in seven to ten (7-10) business days through the same payment method you provided payment with upon being granted Brave Artist Community membership. All Content and associated Member privileges, access, and usage of the Website will be removed within twenty-four (24) hours of refund request approval.

9.4 Refund policy - Workshops

Refund requests for workshop fees must be submitted to help@thebraveartists.com with a receipt number from the email registered at checkout during workshop registration. Refunds requests must be made before fourteen (14) days prior of the start date of the workshop.

Refund requests made between fourteen and three (14-3) days prior to the workshop will be honored at 50% of the purchase price.
